# Minutes of the ANNUAL GENERAL MEETING 2017 held on Monday 8 January 2018 in St Michaels Hall Abergavenny.

#### 1. Attendance.

The meeting, formerly scheduled for 11 December but postponed due to adverse weather, was rescheduled as above. It was attended by the 5 Committee members in office during 2017 and by 14 additional club members. (see Appendix VII for names of those present).

David Straker (DS) Chaired the meeting.

#### 2. Opening remarks.

DS welcomed members to the meeting. Since the Minutes of the AGM of 2016, had been circulated to all members the Accounts and the reports of the Committee would be appended to the minutes of this meeting, he proposed to the meeting that these should not be read out in the meeting.

This was agreed by all present and the meeting then proceeded with a shortened agenda. (see Appendices I – VI for the Committee members reports.)

DS reported that 2017 had been a good year for the Club. Membership had increased. As reported by the Treasurer almost all of the running expenses of the Club had been covered through the revised subscriptions, door payments and raffles.

The judging of Club competitions had provoked much discussion, whilst the external speakers had provided new insights and been entertaining.

#### 3. Adoption of the Minutes of the Annual General Meeting for 2017.

DS asked if there were any queries about the The minutes of the previous AGM or any other matters relating to club activities. Members had no questions nor matters to raise. The minutes of the 2016 AGM were thus approved by common consent.

#### 4. Subscriptions for 2018

The Committee's recommendation that the subscription for 2018 should be held at £55 with payment options the same as for 2017 was approved by the members. The Chair thanked those

members who had paid their subscriptions before the meeting began.

#### 5. Election of Committee.

David Straker reported that he wished to stand down as Chair since he was also Programme secretary and maintained the ACC Web-site. Julie Morgan, the previous Chair and currently Membership secretary, had indicated she was able and willing to take the Chair if required.

The Chair invited nominations from the members present. (No non-attending members had put themselves forward for nomination). Peter Murcutt offered to take on the role of Membership Secretary to fill the gap left by Julie Morgan. The remaining committee members offered to stand again. No further nominations were made. Elections then took place.

# **APPENDIX IV- Competition Secretary's Report**

The table shows the numbers entering the club's competitions in 2017. Altogether, 19 members entered at least one print competition and 21 at least one projected competition. The two groups largely overlap, but in all 23 members took part to some extent.

One thing that stands out is that the themed competitions are less popular, particularly as far as prints are concerned. As a general policy the committee would like to encourage more people to submit prints, so next year we will try having only one themed competition. The May competition will now be open. To give members as much time as possible the themed competition will remain as the November one. Next year the theme is 'Sport' – anything from tiddlywinks to rugby via beach volleyball.

The Panel competition was an innovation that appears to have been successful and welcomed by members, so we will repeat that next year.

The club's participation in external competitions was limited. There were no inter-club battles and we entered only two of the WPF's multi-club competitions. The first was the Barrian Cup print competition where, sadly, we came fourth from bottom. We performed better in the second, Pixels, run by Gwynfa Camea Club, where we were joint twelfth out of 39 clubs.

#### APPENDIX V - Programme Secretary's Report.

The programme for 2017 seemed to go down well. We had talks on panels and a panel competition. We had Mark Lewis telling us how difficult it is to make money selling photos (and he certainly does try). We had artist Sarah Goodey and South Wales star Gareth Martin. We had Ed Cloutman talking about the night sky with amazing astronomy photos and Steve Littlewood with a brilliant show about birds and aircraft. And we had Rob Ashcroft giving us the details on close ups. The 2018 programme is now here:

We start 2018 with an accelerated AGM and a chance to test images you may be thinking of putting in for competitions. We then start locally with a talk on the Gwent Levels before heading off to India's tigers with the brilliant Tal Cohan. The next speaker is a giant in the field who lectured at the

famous Manchester, Guildford and Newport schools of photography. Jack Tait just happens to live in Abergavenny and has agreed to give us a talk on 'how to make a photograph'. Be prepared to be seriously challenged with this one. Later, we have a talk by Alex Stewart on photographing concerts, which will be great as we've already been invited back to photograph the September Jazz Festival (we're also doing a joint exhibition in Red Square with the Jazz Club around Easter time). In the autumn we have Andy Beel, FRPS and another presenter, yet to be announced. In between all this we have competitions, including a repeat of the popular panel evening and a new monochrome competition, and all kinds of member evenings.

## APPENDIX VI – Webmaster's Report

The website is still working ok. I update it occasionally with photographic tips and other updates, such as changes in membership.

I update competitions twice a year as this needs a concerted effort — it takes about four hours per competition to download, resize (twice, including thumbnails) and upload images, then add an entry for each image into a file page for each competition. And there were ten competitions through the year (print and DPI) . PhotoEntry is very helpful in this as all images and scores are in one accessible place. I also updated the 'best photos' page and member pages.

I also update the front page trying to ensure there are images from all members who have entered competitions during the year. Images here are letterbox format so only images that can be sensibly cropped to this ratio are used.

The site is based on Bootstrap, which requires a certain amount technical understanding as the update is via HTML and Bootstrap CSS format. This lets us produce an attractive site and we've had some nice comments about it from other clubs. However it also means it would be hard to hand it over to anyone else without technical knowledge.
